Any students who had not cashed their gran checks were notified and replacement checks were sent as necessary. ** Updated Augus 31, 2020; all grant checks previously distributed had been cashed by students and the Academy maintains no (\$0) student grant monies. Approximately 69 students at Saloi Boutique Academy were eligible to participate in programs under Section 484 in Title IV of th Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act in the event they were financial impacted by COVID. 37 students applied for, qualified for, and received an Emergen Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.

Salon Boutique Academy used the following method to determine which student receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act:

Students were asked to complete an application answering if they had expenses related the disruption of campus operations due to the COVID-19 crisis. They were also asked to include the amount of expenses incurred due to the crisis. These expenses were the grouped into a tier system. Tier One included students with monthly expenses ranging from \$1-1249. Those in Tier 1 received a grant totaling \$500. Tier Two included students with monthly expenses ranging from \$1250-2499. Those in Tier Two received a grant totaling \$1000. Tier Three included students with monthly expenses ranging from \$2500 or more Those in Tier Three received a grant totaling \$2000. All remaining funds are divided evening amongst those who are pell eligible and also applied for and are eligible for the highe education emergency relief fund.
